NOTICE IS HEREBY GIVEN, AS PROVIDED IN MINNESOTA STATUTES 204B.33, THAT A STATE GENERAL ELECTION WILL BE HELD IN FREEBORN COUNTY ON TUESDAY, NOVEMBER 3, 2020, FOR THE PURPOSE OF ELECTING CANDIDATES FOR THE OFFICES LISTED BELOW. THE FILING PERIOD FOR THESE OFFICES BEGINS AT 8:00 A.M. ON TUESDAY MAY 19, 2020 AND ENDS AT 5:00 P.M. ON TUESDAY JUNE 02, 2020.

NOTE: FILING OFFICES WILL BE CLOSED MONDAY, MAY 25, 2020 IN OBSERVANCE OF MEMORIAL DAY AND FRIDAY JULY 3, 2020 IN OBSERVANCE OF INDEPENDENCE DAY.

THE PLACE OF FILING FOR STATE OFFICES IS WITH THE OFFICE OF SECRETARY OF STATE OR WITH THE COUNTY AUDITOR OF THE COUNTY IN WHICH THE CANDIDATE RESIDES.

CANDIDATES MAY FILE IN PERSON OR BY MAIL, IF THE FILING IS RECEIVED DURING THE FILING PERIOD. CANDIDATES WHO WILL BE ABSENT FROM THE STATE DURING THE FILING PERIOD AND MEET THE REQUIREMENTS OF MINNESOTA STATUTES SECTION 204B.09, SUBDIVISION 1A, MAY ARRANGE TO FILE DURING THE SEVEN DAYS IMMEDIATELY PRECEDING THE CANDIDATE'S ABSENCE FROM THE STATE. THIS NOTICE IS SENT BASED ON CURRENT LAW. BE AWARE THAT THE LEGISLATURE AND/OR THE GOVERNOR MAY TAKE ACTIONS THAT COULD AFFECT SOME OF THESE PROCESSES DUE TO THE COVID-19 SITUATION.
